Headteacher's Message - Adele Christofi

Happy New Year and welcome back to all of our community members to what is a very special addition of our newsletter.

As I'm sure you will remember in November we had the very much anticipated visit from Ofsted. The inspection framework changed in September Again, meaning it was more rigorous than before. We had a graded inspection, meaning that they were looking specifically at all 5 key areas; Behaviour and attitudes, quality of education, personal development, leadership and management and the sixth form. We had four inspectors overall , all specialists in their own area of education. The HMI was a specialist in SEND provision and the other inspectors had specialisms in history, English, science and vocational education. The days consisted of lots of meetings with staff, governors and students, work scrutinises, lesson visits, walking the corridors both accompanied and unaccompanied by our staff. Being out and about at break and lunchtime. In a short amount of time they managed to see a huge amount across the school. The process was thorough and very fair.

On the final day, Mr Hubbard, Mrs Seymour and myself were called into the final meeting where they gave their judgments. It was a tense moment! As the inspectors started to deliver their narrative to us we all began to beam. How the inspectors fed back and the positivity they communicated with was both heart warming and somewhat moving. The inspectors proceeded to give a grade for all of those five areas stating that we were good in all of them - and the narrative inferred that we were a strong good, as I am sure you will have picked up in the report. The students were phenomenal and the inspectors categorically said that all the students with whom they spoke (and they spoke to a large number of students) said how proud they felt of their school, how they enjoyed coming to school, they felt the teachers and staff cared about them, they were safe and that they were known as individuals. They also noted how the current outcomes are not reflective of what is going on in the school, as there are legacy issues and students in older year groups haven't had their 5 year journey operating in the same way as we operate the school now.

As the Headteacher of this school this was a pivotal moment and one that I am so immensely proud of. I'd like to thank all of our wonderful staff, governors parents and young people for the incredible support, hard work and effort that you have all put in to improve standards in our school and realise the potential I knew the school had. This is not today that we are complete in our work.

We will now begin phase two of the school's journey, which is really focussed on securing outcomes for all our young people, which we are very excited about. I will ask from all of our community that you share our great outcome with friends, colleagues and neighbours on social media platforms and in any other form of communication as we now need to get the word out that we are #allgood!

These results have been analysed by class teachers and senior leaders so that we can work with the students in order to continue this improvement for the next mock exams, which will start on Monday 24th February.

Inspirational Year 11 assembly - the countdown begins!

This week, Year 11 assembly was led by our headteacher Ms Christofi. She spoke to Year 11 students about how important this time of year is for the and that the hard work has to start today and to continue. With only a few weeks until the next mocks and the written GCSEs starting in May, time is of the essence. Students who do Art, Music, Drama, Languages or Health and Social Care will have exams before this date. Other subjects have coursework for students to complete. Students should be revising for 2-3 hours per evening if they want to achieve well.



Launching period 0 and period 7

To support students with revision in school, this week, all Year 11s have started Period 0. This is targeted intervention which is taking place during the registration period. Mock results have been analysed so that students are getting appropriate support in English, Maths or Science.

From Monday, we will also be starting period 7. This is from 3.15pm-4.00pm. Again students will be directed where they should be going as these sessions will be targeted to improve their grades. Champions Hour will also be available during this time, which is a quiet study space for students to use in school.

All students will be given a prom passport. Staff will be signing these off as students attend their period 7 interventions. Students will need to have attended 30 hours in order for them to be able to attend Prom.

Parents Evening - Wednesday 15th January

Next Wednesday is Year 11 Parents Evening. It will take place from 3.45pm-6.15pm at Laurel Park School. As this is such a vital time for Year 11s, it is compulsory for all to attend. Year 11s will receive their predicted grades that staff have put together based on mock results and effort in class which they may need in order to make applications to post 16 providers.

Year 7 French


Students were learning colours in lesson through a wonderful French poem by Leopold Senghor a Senegalese poet and the 1st African president of the Republic of Senegal.

We have picked up where we left off in our classrooms last term. Below are some of the great work that our students have done this week in Food Technology, Animation and Maths, which continues to showcase the ambition we have for all students at Laurel Park School.







<u>Animation -</u> Our students have had the opportunity to work with Mr Martin who has a lot of experience in the Film industry. They have been learning about the history of Lego and how it is used to create stop animations. They used a zoetrope with hand drawn characters to create a moving scene and made shadow puppets based on the work of German animator, Lotte Reinger. The final piece will be released on our website. Maths – We teach to the top every lesson and Mrs Mohamad's year 10 Maths lesson was no exception. Classroom environment was conducive to learning, coupled with excellent teacher demonstration and independent practice. Students could confidently articulate their knowledge about solving inequalities as they work to master other topics in maths.

Food Technology – Year 11 Food Technology students have been working exceptionally hard to trial the use of different types of ingredients on the outcome of products. Here we see students making pasta from scratch using a variety of flours with varying gluten content. These budding food scientists will use the findings of their experiments to create food products suitable for different sets of people. With the rise in popularity of 'free from foods', our Food Technology students are well placed to leave a lasting mark in our Food and Science industries.

What Parents & Educators Need to Know about JUSTALK KIDS

WHAT ARE THE RISKS?

JusTalk Kids is a child's version of the JusTalk app – a highly popular social networking platform – designed for users up to 13 years of age, allowing them to video call, message and participate in group chats. While adults can link their own JusTalk account to their child's and make use of parental controls, it's important to understand the risks associated with the app.

SUBSCRIPTION FOR PREMIUM ACCESS

While JusTalk Kids is free, there's the option to subscribe to a kids' premium account or a premium family account. At a cost, this feature allows children to have access to more fun features such as games they can play with others in a call; exclusive stickers; a badge denoting them as a premium subscriber; and exclusive ringtones and themes.

RESISTANCE TO CONTROLS

JusTalk Kids endeavours to allow children the sense of having a chat-based app while allowing parents to set controls (within the app or from their own adult JusTalk account). The basis behind this is positive; however, some children are challenging their parents by refusing to use JusTalk Kids, preferring to use the adult version without any restrictions in place.

KNOWING THE PARENT

After downloading JusTalk Kids, parents can set a passcode which users must enter to add contacts. The parental controls help to mange which content can be viewed and who children can add as a contact: this then allows children to chat with friends in a controlled environment. However, prospective contacts don't have to know a specific username. In theory, someone could type in a random name and then add them as a friend.

POTENTIAL DATA LEAKS

JusTalk and JusTalk Kids claim to be secure and encrypted, going so far as to state that even the developers themselves won't access your data. However, a security lapse in 2022 highlighted that messages were not in fact encrypted – leading to concerns around the security of the app and the transparency of the development team.

CYBERBULLYING

Online chats can provide a sense of anonymity, leading some users to post things which they wouldn't normally say in person. Combined with the option of group chats, there's a risk that young people might join in with this kind of behaviour, escalating it further and potentially turning what should be a fun experience into something deeply negative.

TOO MUCH SCREENTIME

A report by the UK Parliament Education Committee highlighted a 52% increase in children's screen time between 2020 and 2022 – as well as finding that 25% of children used their smartphones in a manner consistent with screen addiction. Introducing children to social networking apps when they're too young can lead to bad digital habits and a reliance on technology from an early age.

Advice for Parents & Educators

JUSTIFY THE CONTROLS

If parents allow their child to use JusTalk Kids, they should explain that they're putting parental controls in place to make the app safer. Make sure the child knows not to put their full name on the account and doesn't use a photo of themselves as their profile picture. This type of open discussion will help to ensure that a child is aware of the app's potential risks and knows how to reduce them.

DOS AND DON'TS OF SHARING

Some children might not understand the potential dangers of oversharing online. Set clear guidelines around what *is* and *isn't* safe to share on the internet, and discuss the concept of a digital footprint. Children need to understand that the things they say and share online can never be completely erased. Even if they delete it themselves, it can be saved and distributed by others.

ENCOURAGE OPEN COMMUNICATION

Apps like JusTalk can sometimes lend themselves to bullying behaviours. Parents should monitor what their child is sending and receiving, check in with them regularly and encourage them to share their feelings (both positive and negative) at home. Remind them that they can block a contact if someone is treating them disrespectfully.
